

# WEIMAR FFA STOCK SHOW

## GENERAL INFORMATION AND RULES

*\*\*These rules are subject to change following the completion of each year's stock show\*\**

### GENERAL INFORMATION

1. Weimar FFA Chapter adheres to the National FFA Constitution and By-Laws that specifically states "a student **MUST** be enrolled in an Ag Science class in order to be eligible for FFA membership." Students must be an FFA member in order to be eligible to show and sell an animal at the Weimar FFA Stock Show.
2. Projects require time EVERY DAY for feeding, cleaning, and exercising.
3. FFA members are not required to raise a project. This is a privilege, **NOT** a right, and should be treated as such.
4. There is the potential for the loss of money with any project.
5. All pens must be predator proof.
6. All poultry must be purchased from the chapter but all other projects are to be purchased by students independently.
7. Advisors will assist with advice regarding animal purchase upon request.
8. Only fryer rabbits may be sold at the Weimar FFA show.
9. The Weimar FFA Stock Show will be held on the second Friday of February at the Weimar FFA "Mac Glover" Show Facility.
10. The Weimar Agriscience teachers will be more than willing to visit and assist with a project at any time by request.

### ELIGIBILITY REQUIREMENTS

1. FFA members may **NOT** miss more than 2 FFA meetings to be eligible to show (Meetings are held in April, September, October, November, December and January). The April meeting prior to a 9<sup>th</sup> grader entering high school will not count against them). There will be a mandatory show meeting immediately following the September FFA meeting.
2. In the event a failing grade was made in any class the 6-weeks prior to the show, grades will be checked weekly to determine a current passing grade in the class is in place and eligibility for show purposes will occur.
3. A minimum of 5 buyer invitation letters (3 local, 2 out of town) must be turned in with stamped, addressed envelopes by the Wednesday **BEFORE** Christmas break – 12/12/2022. (\$5/day penalty).
4. Members must complete all requirements on the 'points page' to participate in the Weimar FFA Stock show and sale (**this includes**: missing no more than 2 FFA meetings, volunteering at a minimum of 1 WeCAN Food Pantry distribution, selling/earning \$250 in fundraising dollars, participation in 2 additional community service activities which can include We CAN Food Pantry distribution, earning 2 or more concession credits)
5. Conduct unbecoming of a Weimar FFA member will result in the automatic

disqualification of an exhibitor at the discretion of the Agriscience teachers and Weimar ISD administration.

### GENERAL SHOW RULES

1. The Weimar FFA advisors and their designees shall have the power to act on any of these rules.
2. Any member not meeting all eligibility criteria by the designated date will not be allowed to participate in the stock show or auction.
3. A member who wins the showmanship/market contest will be eligible to enter the contest again.
4. Judges will be selected on a 2 year rotation.
5. Entry fees will be \$10 per animal/pen entered, due one week prior to show.
6. Weight class breaks will be determined at the discretion of the Agriscience teachers.
7. The chapter will retain a 4% commission on all show monies received from the stock show.
8. Students who exhibit broilers must pay for them before picking up their animals.
9. Students who show broilers and rabbits must deliver the animals already processed within 10 days of the show upon request of the buyer\*\*\*
10. Students can tag in or purchase as many animals as desired, BUT they are allowed to show no more than 2 large animal species and NO MEMBER MAY SELL MORE THAN ONE ANIMAL OR PEN.
11. No student will be allowed to win both Grand and Reserve in the same species during the same year. (Once one animal has been chosen Grand, the second animal will move out and the next in that class will be moved up for consideration.)
12. Each exhibitor must attain at least two (2) Concession Stand Credits. These credits can be earned by the exhibitor and/or his/her parent(s) by working at the concession stand during Varsity, JV, or Junior High football games during the 2022 season and/or at the concession stand during the sale (VERY limited spots and time at sale).
13. Each student must wear official dress for the sale (brown boots and pants for girls will be permitted)
14. Each student must wear blue jeans, a white collared shirt, an FFA jacket, and a scarf/tie while showing his/her animal in the ring.
15. \*\*\*All exhibitors MUST attend a barn setup day\*\*\*
16. \*\*\*All exhibitors must attend barn clean-up the afternoon of the livestock show to set up for the auction. \*\*\*
17. \*\*\*At the conclusion of the auction, all exhibitors must stay to help clean-up the barn and transport livestock to their destinations. \*\*\*
18. Members must complete an official FFA Record Book before receiving their show earnings.
19. \*\*\*Members **MUST** send a "Thank You Note" to ALL of their buyers, buckle, banner, and add-on donors. Thank you notes must be turned in to the Ag department in a stamped, addressed envelope within 2 weeks of the show\*\*\*\*
20. \*\*\*A mandatory sale meeting will be held following a brief lunch break. The time of this meeting will be announced during the show, **ALL** exhibitors **MUST** attend\*\*\*
21. Animals that do not meet quality standards as determined by the Ag teachers at the time of check-in will not be allowed to show or sell.

22. Large species animals that do not meet minimum weight requirements will be permitted to sell for resale value only.
23. All animals are to be tagged-in by a pre-determined date which will be announced during the first month of each school year.
24. All animals will be sold by the head, not by the pound.
25. No animal can be double entered.
26. There must be at least 3 exhibitors to make a sale species.
27. Weigh in for ALL LARGE ANIMALS (steers, pigs, lambs, goats) will be on Thursday evening prior to the show. Small animals (rabbits, broilers) will be weighed in Friday morning. The gate will be locked at 9pm and reopen on Friday at 6:30am. All exhibitors may weigh as many times as needed during their respective weigh in time frame, but once an allowable weight has been reached no re-weighs will be allowed.
28. Changes/Additions to regulations may be made at the discretion of the Agriscience teachers as deemed necessary. The Agriscience teachers have the final say in regards to all show decisions.
29. Drench guns may not be used in the barn or on school premises. Stomach pumping, drenching tubes or any other method (by esophagus) is prohibited.
30. Exhibitors must be a Weimar High School student and FFA member enrolled in an Agriculture, Food and Natural Resources class in order to show any species.

## **PENALTIES**

\*\*\* Rules 11, 14, 15, 16, 17, 18, 19 will each result in a \$100 penalty.

\*\*\*\* No check will be issued until thank you notes have been turned in!

*All penalties and money owed to the chapter (including the cost of buyer and award picture(s)) will be automatically deducted from show checks.*

## **(Up Dated for 2023 Show)**

### **STEERS** (TAG-IN will be 9/14/2022)

1. There will be NO weight limit for steers on tag in date (as a point of reference, suggested weights are 500-800lbs). Weight at show is 900lbs minimum and 1400lbs maximum.
2. Tag-in will be set for early September at Oak Grove Veterinary Clinic.
3. Market steers should abide by Houston Livestock Show Rules in regards to clipping (<1/4" hair).

### **MARKET SWINE** (TAG-IN will be 11/07/2022)

1. May show either barrow or gilt.
2. Hogs must be tagged on a predetermined date during the first week of November (specific date TBA during the first month of school).
3. Weight limit at the show will be 200lbs minimum to 300 maximum with a five pound scale tolerance.
4. Market swine hair may be trimmed to a length of 3/4".

**MARKET LAMBS** (TAG-IN will be 11/04/2022)

1. May show either a wether or ewe.
2. Lambs must be tagged on a predetermined date during the first week of November (specific date TBA during the first month of school).
3. Weight limit at the show will be 90lbs minimum to no maximum with a five pound scale tolerance.
4. Lambs must be slick shorn and of uniform length from knee and hock up. "Blocking" is not allowed.

**MARKET GOATS** (TAG-IN will be 11/04/2022)

1. May show either a wether or doe kid.
2. Goats must be tagged on a predetermined date during the first week of November (specific date TBA during the first month of school).
3. Horns must be tipped on all goats prior to show (not less than the diameter of a dime at the end).
4. Weight limit at show is 60-115lbs with a 5 pound scale tolerance.
5. Goats will be shown with a show chain or collar.
6. Goats must be slick shorn and of uniform length from knee and hock up. "Blocking" is not allowed.

**POULTRY** (ORDERS due 09/23/2022)

1. All birds must be bought through the chapter.
2. Broilers are shown in a pen of 3.
3. Broiler pen must collectively weigh at least 12 pounds with a ½ pound scale allowance.
4. Delivery of broilers will be determined by hatchery.

**RABBITS** (TAG-IN will be held 1/9-13/2023 after school)

1. Each pen will consist of 3 rabbits, either sex, approximately 70 days old. (Breed 100 – 103 days prior to show.)
2. Rabbits within the pen shall be the same breed and weigh no more than 5 1/2 pounds or less than 3 pounds with a ½ pound weight allowance.
3. Rabbits must be of a recognized commercial breed – example: New Zealand and California or can have a mixed breed between the two.
4. Exhibitors are responsible for finding and purchasing their own rabbits. It is **IMPORTANT** to contact a breeder AS SOON AS POSSIBLE!
